## **Reminder for Grandparents!**

<ul> <li>Ofcom to enforce new Online Safety Rules!</li> <li>From 25th July 2025, all sites and apps that allow pornography will need to have strong age checks in place, to make sure children cannot access it or other harmful content.</li> <li>Why?</li> <li>• 8% cent of children aged 8-14 in the UK visited an online porn site or app in a month,</li> <li>• Boys aged 13-14 were mostly likely to visit a porn service.</li> <li>• Ofcom's research shows the vast</li> <li>majority of adults (80%) support age checks on online pornographic sites as a means of protecting children.</li> <li>How Ofcom will enforce the rules</li> <li>• Ofcom expects sites and apps to engage with them and comply with their duties under the new rules.</li> <li>• Ofcom will be able to impose fines of up to £18m or</li> </ul>	<ul> <li>With the summer holidays fast approaching we remind Grandparents of the UK Safer Internet Centre's (UKSIC) resource to <u>support grandparents with online safety</u>.
