Dear Parents

We have been finalising arrangements for the Class 1 residential that you paid a £30 deposit for back in the Autumn Term. There are two potential scenarios regarding the transport arrangements.

Firstly, the NCLT has ordered two new minibuses that should be with the MAT by May. Mrs Hart and I will be able to drive these to take the class to Penzance and use them to explore the surrounding area. Mrs Arnott and Mr Warren will be the additional adult in each minibus.

If the minibuses do not arrive in time for our residential, we will go back to the original plan of catching the train from Bodmin to Penzance and using the open top Explorer Bus to visit Land's End and view the peninsula.

There are therefore two possible costing scenarios. If we use the minibuses, the cost will be approximately £160 (£120 if we are in receipt of Pupil Premium for your child). If we use the train and bus, the cost will be approximately £180 (£140 if we are in receipt of Pupil Premium for your child). As you have already paid a non-refundable deposit of £30, in the first instance, you need to pay another £130 (£90 if we are in receipt of Pupil Premium for your child) by the end of May and complete the consent form below. School Money will be set up so that you can pay in instalments if you so wish. If by the end of May, the minibuses look unlikely we will make train booking and adjust the price accordingly.

The above prices include transport, YHA bed, breakfast and packed lunch, evening meal in a restaurant (TBC), entrance to Land's End attractions (4D cinema & Arthur's Quest), day trip to the Isles of Scilly and an ice cream!

If you would like any further details regarding the residential, please do not hesitate to ask. As I have organised this trip on a few previous occasions, I feel confident that I will be able to answer most questions.
